My dissertation defends an original relativist theory of the nature and sources of our different kinds of normative reasons, including especially moral reasons and also reasons of practical and epistemic rationality. I draw from the growing literature on group agency in order to inform a novel approach to meta-ethics that is consistent with some of the key motivations for antirealist and relativist views, including epistemological objections to realism.
